

Privacy Policy – My Dungeon

This Privacy Policy describes how we collect, use, and share your personal information when you visit or make a purchase on www.my-dungeon.com.

1. Information We Collect

Device Information

When you visit the Site, we automatically collect certain data about your device, including:

- Browser type, IP address, and time zone.
- Cookies stored on your device.
- Pages you visit and how you interact with the Site.
- Websites or search terms that referred you to our website.

We use technologies, tags, and pixels to help analyze how users navigate the Site.

Order Information

When you make a purchase, we collect:

- Name, billing address, email, and phone number.
- We do not store credit card information; payments are processed directly through PayPal and Stripe.

When we refer to "Personal Information" in this Privacy Policy, we mean both Device Information and Order Information.

2. How We Use Your Information

We use the collected information to:

- Process orders and send confirmations.
- Communicate with you.
- Assess fraud risks and security.
- Display targeted ads on platforms like Facebook.
- Improve the Site by analyzing user navigation and behavior.

3. Sharing Your Information

We may share your information with third parties who help us operate the Site, such as:

- Google Analytics: helps us understand user interactions. More details at the Google Privacy Policy. To opt out, visit the Google Analytics opt-out page.
- Targeted Advertising: we use data to show relevant ads on platforms like Google and Facebook. You can opt out at Facebook, Google Ads, or the Digital Advertising Alliance.

Additionally, we may share your information to comply with legal requirements, respond to government requests, or protect our rights.

4. Do Not Track

We do not alter our data collection practices when receiving a Do Not Track signal from your browser.

5. Your Rights
